**Job Title:** Housing Support Worker (Core & Community Cluster Team)

**Hours:** 37 hours per week

## Outline of Post

Turning Lives Around is part of a consortium delivering the Our Way Leeds service; a housing related support service for vulnerable young people, aged 16-25, including those leaving care who are moving into independent living for the first time. The service is regulated by Ofsted. The consortium has GIPSIL as the lead provider, alongside Turning Lives Around and Foundation.

Support workers work under the guidance of the Registered Service Manager and team leaders within Ofsted's regulatory framework, to support young people's individual needs, maximise independence and work towards successful move-on into independent living.

This post is for a Housing Support Worker in the Core & Cluster service, consisting of a four-bed shared property with a staff office on site, and 11 units in the nearby community.

The role of Housing Support Worker is key to providing high-quality support for our young people and ensuring that risk and safeguarding issues are addressed.

Housing Support Workers carry a 'case load' of young people and provide regular 1 to 1 support in young people's homes and within the community up to three times a week.

One of the key principles of service delivery and Ofsted regulation is that the voice of young people is central to the planning and delivery of effective support.

The Core & Cluster service operates 24 hours a day, 7 days a week. An example of the rota for the housing support worker post can be found below. The shift pattern includes bank holidays:

E= 7:30am – 3:30pm

M= 9:00am - 5:00pm

L= 1:00pm – 21:00pm

Each shift = 7.5 working hours

Please note this job description is intended to provide a guide to the general duties and responsibilities of the role. The post holder is expected to adopt a flexible approach to the tasks. It should not be regarded as a contractual document. It will be reviewed regularly and may be varied at the discretion of Turning Lives Around and the Our Way Leeds Partnership.

## Main Responsibilities:

1. Develop positive and collaborative relationships with young people, partner agencies and families, if appropriate.
2. Work alongside young people and other agencies, if relevant, to develop and review support plans and risk assessments, to ensure young people's needs are met
3. Ensure young people are provided with information and guidance to access relevant services and support
4. Raise and manage safeguarding concerns as appropriate and act in accordance with OWL and Turning Lives Around safeguarding policies and procedures.
5. Respond to emergencies and prioritise workload effectively
6. Maintain timely and accurate records of all aspects of a young person's support.
7. Maintain appropriate professional boundaries at all times
8. Prepare and manage void accommodation in line with service targets
9. Support young people to move into accommodation
10. Support young people to develop their independent living skills and manage their tenancy, such as practical help with cooking, budgeting, paying rent and service charges, being a good neighbour and emotional support
11. Carry out any required health and safety checks and report repairs in a timely manner, which may involve liaising with contractors.
12. To take part in regular, reflective supervision and appraisals to ensure both the maintenance of a good quality service and also personal and professional development.
13. To attend any required training that will increase proficiency in the delivery of this service.
14. To attend any meetings as deemed necessary by line management.
15. To contribute to the effective monitoring and evaluation of this service and ensure positive outcomes are evidenced.
16. Keep up to date and work in accordance with policies, guidelines, procedures and practices, including Ofsted regulation requirements
17. To work specifically with the organisation's Equal Opportunities and Diversity Policy, promoting diversity and difference in all aspects of the work.
18. You may be required to perform any other duties as the organisation may reasonably require. You undertake to work to the best of your ability and use your best endeavours to promote, develop and extend the group's business interests.
